# PRODUCT APPLICATION

### CONSTRUCTION

The Sani-Ray® Germicidal Ultraviolet Recessed Fixture consists of:

- **STER-L-RAY**<sup>®</sup> Germicidal Ultraviolet Lamp(s), which delivers ultraviolet energy at the specific wavelength of 254 nanometers (nm). This wavelength is highly effective against microbes, including virus, bacteria, and mold spores.
- Surelite<sup>™</sup> Electronic Ballast(s) capable of operating at 120v 50/60Hz or 230v 50/60Hz. Other power supplies may be available. Contact factory for specifics.
- All electronics and wiring are housed in an enclosure constructed of stainless steel. Stainless steel construction provides strength, durability and lasting value.
- A polished reflector, whose design and specular aluminum construction maximizes ultraviolet intensity to the exposed area.

### **P**RINCIPLE OF **O**PERATION

The **Sani-Ray**<sup>®</sup> design has been carefully conceived to provide germicidal ultraviolet dosage for air and surface disinfection in <u>unoccupied</u> space to disinfect and prevent areas and surfaces from microorganisms. The dosage, as it applies to ultraviolet disinfection, is a function of time and the intensity of ultraviolet radiation, to which the air and surface is exposed. The exposure time, in seconds, is the total time it takes the air to move through the ultraviolet field, produced by the germicidal lamp(s). Exposure time is related to the airflow rate; the higher the airflow, the lower the exposure time or the lower the airflow, the higher the exposure time. The UV intensity is the amount of energy, emitted by the germicidal lamp(s).



**AWARNING** Avoid exposure to direct or reflected germicidal ultraviolet rays. Germicidal ultraviolet rays are harmful to the eyes and skin.

### LIMITATION OF USE

- The **Sani-Ray**<sup>®</sup> requires professional installation by a licensed electrician; so all wiring complies with applicable state, local, and national electrical and mechanical codes.
- **Sani-Ray**<sup>®</sup> requires knowledgeable planning for: location, installation, and supervision to prevent ultraviolet exposure of occupants to direct or reflected ultraviolet rays.

**CAUTION** Overexposure to germicidal ultraviolet rays will result in the irritation of the eyes and reddening of the skin. For this reason, it is of the utmost importance that your ultraviolet application be carefully planned and implemented so as to avoid exposure of occupants, to direct or reflected ultraviolet rays.




Personal protection equipment is required when entering the irradiated space with the germicidal lamp(s) operating. Personal protection equipment includes skin and eye protection such as gloves, long sleeves with no gaps between cuff and gloves, and an ultraviolet resistant face shield.

- The American Conference of Governmental Industrial Hygienists (ACGIH) has established that the ultraviolet radiant exposure incident for unprotected eyes or skin should not exceed 0.2 microwatts per square centimeter (μW/cm2) at 254 nanometers (nm) for an eight (8) hour period. ("2004 TLVs<sup>®</sup> and BEIs<sup>®</sup>")
- Safety and maintenance procedures <u>MUST</u> be implemented to prevent exposure of personnel and other persons who may be in and around the area. All work performed in the irradiated space must be monitored to ensure that it does not adversely impact the safety or effectiveness of the installation.
- To monitor and test ultraviolet intensity, see "Zenith™ Germicidal Ultraviolet Detector" in the "Optional Accessories" section.

\* The Threshold Limit Values (TLVs<sup>®</sup>) and Biological Exposure Indices (BEIs<sup>®</sup>) are developed as guidelines to assist in the control of health hazards. ## **UNPACKING**



- Remove the Sani-Ray® Germicidal Ultraviolet Recessed Fixture from its shipping carton.
- Atlantic Ultraviolet Corporation<sup>®</sup> takes all possible precautions when packaging this fixture to prevent damage. Carefully inspect the fixture, power cord and plug if applicable, for damage, report all damage immediately. Do not assemble or operate if there is any damage, visible or suspected.
- Germicidal lamp(s) are packed separately, to ensure maximum protection for the lamps. Keep the lamp(s) aside until ready for installation.
- Carefully inspect all packing materials to prevent the loss of accessories, mounting hardware, spare parts or instructions.
- Do not discard packing materials until fixture is assembled and check out is complete.

# INSTALLATION ——

#### **ACAUTION** Access to area <u>MUST</u> be avoided when Sani-Ray<sup>®</sup> fixture is operating.

### FIXTURE PLACEMENT

Proper fixture placement is essential. To ensure safe and effective operation, the location should:

- Have an appropriate power source matching power requirements listed on the fixture label.
- Not be mounted under any source of moisture or condensation.
- Prevent exposure of any plastic, rubber or other non-metallic materials, with inadequate resistance to ultraviolet. If necessary, shield all plastic, rubber or other non-metallic parts using aluminum tape, or equivalent ultraviolet resistant material.
- Be free of any components that would be damaged by or interfere with the installation.
- Be easily accessible and allow enough clearance for routine cleaning and maintenance.






Figure 1 – Sani•Ray<sup>®</sup> RRDxx-1S / RRDxx-2S, RRDHOxx-1S / RRDHOxx-2S

### INSTALLATION



# IN ORDER TO PERFORM THIS TASK, BE SURE TO WEAR THE FOLLOWING SAFETY EQUIPMENT: SAFETY GLASSES OR A FACE SHIELD, AS WELL AS GLOVES.

### **ACAUTION** Access to area <u>MUST</u> be avoided when Sani-Ray<sup>®</sup> fixture is operating.

- 1. All standard **Sani-Ray**<sup>®</sup> fixtures:
  - Are not equipped with a power cord and require professional installation so all wiring complies with applicable state, local and national electrical and mechanical codes.
  - Require removal of the cover to complete input power wiring.
  - Require suitable wire nuts or other approved interconnecting method to connect the **Sani-Ray**<sup>®</sup> ballast wiring to utility input power wiring.
  - Require an adequately sized ground wire. An 8-32UNC stud, located inside the chassis, is provided for securing the ground wire to the **Sani-Ray**<sup>®</sup> chassis.
  - Have two 7/8" trade size knockout plugs, for standard electrical fittings.
- 2. After fixture is mounted and wired, install lamp(s) following the steps in "Lamp Installation, Replacement, or Cleaning" in the "Maintenance" section.

### PRECAUTIONS

- Procedures <u>MUST</u> be adopted to ensure that the Sani-Ray<sup>®</sup> is disconnected from power whenever anyone (personnel, contractors etc.) works or is in the irradiated space. Any person who works in and around the fixture <u>MUST</u> be briefed on the precautions to be observed.
- If there are any doubts or concerns about the safety or the effectiveness of the installation, or if a sensitive ultraviolet meter is required, please contact our Application Specialists. (See "Zenith™ Germicidal Ultraviolet Detector" in the "Optional Accessories" section.)

# MAINTENANCE

### Always disconnect power to the fixture before performing any service or maintenance.

- The **Sani-Ray**<sup>®</sup> is designed to operate with a minimal amount of maintenance.
- A regular cleaning schedule of the **STER-L-RAY**<sup>®</sup> Germicidal Lamp(s) <u>MUST</u> be established, and carefully maintained, based on visual inspection and experience. The frequency between cleanings will vary with the conditions surrounding each installation. It is recommended that the ultraviolet lamp(s) be cleaned at least once every three (3) months.
- The **STER-L-RAY**<sup>®</sup> Germicidal Ultraviolet Lamp(s) used in the **Sani-Ray**<sup>®</sup> have a manufacturer's rated effective life of 10,000 hours for standard instant start lamps and 13,000 hours for high output lamps. Lamps may operate longer than their rated effective life, but the reduction in ultraviolet output will make it impractical to use past the manufacturer's rated life. For maximum efficiency lamp replacement is recommended after about one (1) year of continuous use.
- Unless lamp replacement is due to failure or breakage, it is recommended that all lamps be replaced at the same time.

### LAMP INSTALLATION, REPLACEMENT, OR CLEANING



IN ORDER TO PERFORM THIS TASK, BE SURE TO WEAR THE FOLLOWING SAFETY EQUIPMENT: SAFETY GLASSES OR A FACE SHIELD, AS WELL AS GLOVES.

### Always disconnect power to the fixture before performing any service or maintenance.

#### **ACAUTION** Ultraviolet lamps are easily damaged. Exercise care when handling lamps.

- 1. Disconnect power to the fixture.
- 2. **Remove STER-L-RAY® lamp(s)**, carefully press lamp against the spring-loaded lampholder. When the **STER-L-RAY®** lamp pin clears the stationary lampholder, pull lamp out and away from fixture.
- 3. Moisten a clean, lint-free cloth with denatured alcohol and clean lamp(s).
- 4. When **STER-L-RAY**<sup>®</sup> lamp(s) have been removed and cleaned, safely set aside.
- 5. The reflector of the **Sani-Ray**<sup>®</sup> is constructed from specular aluminum, a highly reflective mirror like material, used to maximize ultraviolet intensity. To remove any dust, dirt, fingerprints, smears, etc, from the outer surfaces of the reflector, moisten a clean, lint-free cloth with denatured alcohol and wipe down the reflector. Buff out any streaks, left from the cleaning, using a soft dry cloth.
- 6. **Install STER-L-RAY**<sup>®</sup> **lamp(s)**, insert lamp pin into spring-loaded lampholder. Carefully press lamp against the spring-loaded lampholder. Align lamp pin with stationary lampholder. Slowly ease the pressure until lamp is fully seated in lampholders.
- 7. Verify that lamp(s) is properly seated.
- 8. Repeat until all lamps have been cleaned and properly installed.
- 9. Restore power to the fixture.

10. Wear personal protection equipment such as gloves; long sleeves with no gap between cuffs and gloves, and ultraviolet face shield, then verify operation by viewing lamps(s). If the fixture is not operating properly, go to "**Troubleshooting**" section.

### BREAKAGE

### **ACAUTION** Broken Quartz is SHARP.



Wear protective gloves when handling broken ultraviolet lamp(s). In the event of breakage, **<u>DO NOT</u>** use a household vacuum cleaner to pick up quartz fragments. Sweep up debris into a plastic bag and dispose of properly.

### DISPOSAL OF MERCURY ADDED LAMPS



Germicidal ultraviolet lamps, like standard fluorescent lamps contain small amounts of mercury. Mercury added lamps should not be placed in the trash. Dispose of properly. - 1. ArmorLite<sup>™</sup> Germicidal Ultraviolet Lamp Safety Shield: Protective coating applied to STER-L-RAY<sup>®</sup> Lamps ensures protection by eliminating the dangers associated with fragments of broken quartz and mercury contamination.
- 2. Zenith<sup>™</sup> Germicidal Ultraviolet Detector (30-1015): A sensitive, hand-held, self-contained battery operated ultraviolet meter that can be used for:
  - Monitoring UV-C Germicidal Lamp Intensity & Aging
  - Measuring UV-C Germicidal Fixture Leakage.
- 3. SENTINEL<sup>®</sup> Germicidal Ultraviolet Lamp Operation Indicator: (Must be ordered at same time as Sani-Ray<sup>®</sup> fixture.) Monitors lamp operation of one-lamp (35-4502A1) two-lamp (35-4502A2) or four-lamp (35-4502A4) germicidal ultraviolet fixtures, and can be mounted using 25, 50 or 100 foot cables.
- 4. **Promate™ Safety Glasses (00-1299):** Safety eyewear <u>MUST</u> be used as general-purpose safety protection and for additional shielding from ultraviolet rays
- 5. **Promate™ Face Shield (00-0126):** Lightweight visor with adjustable headgear provides eye and face protection from germicidal ultraviolet rays.
- 6. Promate <sup>™</sup> Danger Signs (98-1802): Glossy card stock 5.5" x 4.25" signs to be affixed to entry door(s) to warn that an ultraviolet sanitizer is in use and that the treatment area <u>MUST</u> not be entered. Sani-Ray<sup>®</sup> is for use only in <u>unoccupied</u> areas. Two (2) signs are included with each model; additional signs may be purchased. <u>NOTE</u>: Danger Signs have English on one side and Spanish on the other.
- 7. **Assure**<sup>™</sup> **UV-C Dosimeter (00-0376):** A portable, full-featured instrument that provides highly-accurate UV-C measurements in mJ/cm<sup>2</sup>. Sits upright, on back or side, and can be placed in supplied wall holder. Uses 1 AAA battery.
- UV-C Dosimeter Card (00-0373): Contains a patented colorimetric indicator that changes color at 25, 50, and 100 mJ/cm<sup>2</sup> to visibly confirm that your Sani-Ray<sup>®</sup> is achieving the desired UV-C exposure. Each card is designed for one (1) treatment cycle and <u>CANNOT</u> be reused. Complete instructions for use are on back of card.
- Personal UV-C Exposure Indicators (00-0375): These indicators change color to reveal the word "STOP" if personnel are exposed to an accumulated dose of 6 mJ/cm<sup>2</sup> of UV-C irradiation. Adhesive backing sticks to clothing. Available in packs of 10. Designed for single, daily use and <u>CANNOT</u> be reused.
- Other accessories, such as: handles, standoff legs, brackets for ceiling mounting, power cords and **ON/OFF** switches and lamp guards are available.
